1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .In case

7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Security Printing Press, Hyderabad payable at Security Printing Press, Hyderabad

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

4. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

6. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

7. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(I) Special Conditions of Contract (SCC):-

(1) Bid Splitting/Parallel Contract:- The Purchaser reserves the right to place 100% quantity on lowest quali fied bidder. However, the Purchaser also reserves the right to place parallel contracts on maximum of two firms, without any prejudice to the capacity of the L1 bidder, as given below:-

(a) The rate quoted by L1 bidder will be counter offered to L2 bidder, without prejudice to the capacity of t he L1 bidder and if agreed orders shall be placed in the ratio of L1:L2 = 70:30 of the total tendered quantit y. In case of non-acceptance of the counter offer by L2 bidder, a similar offer shall be made to L3, L4 and s o on at the sole discretion of the purchaser.

(b) However, purchaser also reserves the right to place the order for the 100% tendered quantity on the lo west qualified bidder in case any of the L2, L3 and so on does not accept L1 rates.

(2) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the service s within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered pric e of the delayed goods and/or services for each week of delay or part thereof until actual delivery or perfor mance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of t he delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and /or performance, the conditions incorporated under GCC sub-clause 24 above shall also apply. In all such c ases GST would also be applicable on LD.

(3) Licenses and Permits: Wherever applicable, the successful bidder shall ensure himself and also satisfy t he Chief General Manager, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting Cor poration of India Limited, that the successful bidder possesses the legal licence / permit to use a particular product / process /design / patent. The successful bidder shall be held responsible for all the civil/criminal and tortuous consequences arising from any claim from any third party in this regard. (4) Risk Purchase: (a) If the supplier after submission of tender and due acceptance of the same i.e. after is sue of Notification of Award of Contract fails to abide by the terms and conditions of these tender documen ts, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall have the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternat ive arrangement and supplier tendered value will be recovered from the supplier along with other incident al charges, including taxes, insurance etc.

(5) Tender cancellation: The Chief General Manager, Security Printing Press, Hyderabad, India reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to cancel t he tendering process and reject all tenders at any time prior to award of contract, without incurring any lia bility, whatsoever to the affected tenderer or tenderers.

(6) Fall Clause: If the supplier reduces its price or sells or even offers to sell the contracted goods, followin g conditions of sale similar to those of the contract, at a price lower than the contract price, to any person or organisation during the currency of the contract, the contract price will be automatically reduced with ef fect from that date for all the subsequent supplies under the contract and the contract amended according ly. Any violation of the fall clause would be considered a serious misdemeanor under clause of the GIT and action, as appropriate, would be taken as per provision of that clause.

(7) Termination of Contract: Security Printing Press, Hyderabad reserves the right to terminate the contract t at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on account of such termination of the contract or variation in the quantity.

(8) Cancellation of Contract for Default: Without prejudice to any other remedy for breach of contract, like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:

(i) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, o r any extension thereof granted.

(ii) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.

(9) Termination of Contract for Convenience: After placement of contract, there may be some unforeseen si tuation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to the sup plier for cancellation of the contract, in whole or in part, for its (SPMCIL#s) convenience, inter alia, indicatin g the date with effect from which the termination is to become effective. Depending on the merits of the c ase, the supplier may have to be suitably compensated on mutually agreed terms for terminating the cont

ract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resul tant contract.

(10) PVC Clause:- No Price Variation will be permitted.

(11) Warrantee Clause: Warranty applicable for 3 months from the date of last supply.

(12) Price Adjustment Clause: No Price Adjustment allowed.

(13) Any dispute in the matter will be under Hyderabad (Telangana) Jurisdiction only.

(14) No revised quotation will be permitted during the validity of the bid and no conditional bid shall be acc epted.

(II) Delivery Schedule:-

- (a) 1St lot of 6 MT should be supplied within 45 days from the date of placement of Contract Order.
- (b) 2nd lot of 12 MT should be supplied within 3 months from the date of placement of Contract Order.
- (c) 3rd lot of 12 MT should be supplied within 5 months from the date of placement of Contract Order.

The above Delivery Schedule may be changed in case of any operational exigencies.

(III) Quality Control Requirements:-

Pre-Despatch Inspection:-

(a) Security Printing Press, Hyderabad will conduct a Pre-Despatch Inspection at the manufacturer's premi ses for examination of the material before despatch to Security Printing Press, Hyderabad.

(b) The supplier shall communicate the readiness of the material for inspection at least 07 days (30 days i n case of foreign supplier) prior to the scheduled date of dispatch as per the Purchase Order, in order to en able Security Printing Press to depute its representatives for the inspection at the manufacturer's premises . The details of the representatives deputed shall be conveyed in advance to the supplier.

(c) The supplier shall ensure that all the equipment necessary for testing of the parameters of the material are calibrated and in working condition made available at the place of inspection, If adequate test equipm ent is not available then the same shall be reported in the inspection report.

(d) Before the firm invites for PDI at the manufacturer's work site, the firm should ensure that all test are c onducted and lab reports should be kept ready for inspection.

(e) If the PDI test results are found ok, then the Dispatch Clearance Certificate will be issued by SPP repres entative.

(f) All expenses towards travel, boarding and lodging and other miscellaneous expenditure and daily allow ances shall be borne by the purchaser.

(g) The right for waiving the Pre Dispatch Inspection is reserved with the Chief General Manager of Security Printing Press, Hyderabad, India and the supplier shall despatch the material only after getting the certifica tes of waiver of PDI, in the event of inspection is not contemplated.

Note : "The Dispatch Clearance Certificate" is not final acceptance of the material.

(h) In case the PDI is waived off, the supplied material may be allowed inside Security Printing Press, Hyder abad on the manufacturer's test report subject to testing at Security Printing Press, Hyderabad or any Gov t. / PSU laboratories.

(i) After the Pre-Despatch Inspection from the discretion of the inspecting officials as per the inspection re port the material may be despatched to Security Printing Press, Hyderabad. However, the material shall b e tested at Security Printing Press, Hyderabad or at any Govt. / PSU laboratories.

(j) If the test results are not found ok at SPP, Hyderabad or any Govt. / PSU laboratories as per technical sp ecifications then the entire lot will be rejected.

(k) On receipt of the lot, the material supplied will be inspected for conformity of technical specification at SPP, Hyderabad or any Govt. / PSU laboratories.

(I) The runnability test will be done only after complying all the technical specifications as mentioned in th e tender.

(m) If the material got rejected, then lifting of rejected material will be allowed only after supply of good m aterial in lieu of the rejected lot.

(n) If material supplied against replacement got rejected, then the firm has to lift all the rejected material and contract/Purchase order will be terminated as per tender terms and conditions of tender.

(o) If the material accepted by user section after conformity of technical specifications / runnability of the material, then payment of that lot will be processed accordingly.

(IV) Payment terms:- 100% payment within 30 days after receipt & acceptance of material by consignee as mentioned in Delivery schedule. No payment shall be made for rejected material.

Note: SPPH GST No. 36AAJCS6111J1Z9 should be mentioned in all the tax invoices and bills.

(V) Qualification/Eligibility Criteria:- The Bidder should meet the following eligibility criteria to qualify:-

(1) Experience and past performance: The bidder should have manufactured and supplied at least 12 MT o f Sensitized Cream Wove Chq. Paper or similar material to any organisation in any one year during last five

years.

Note: 'Startups and Micro and Small Enterprises' are exempted from Experience and Past Performance Crit eria as per the MSE Policy.

(2) Capability-Equipment & Manufacturing Facilities: The bidder firm must have an annual capacity to Man ufacture and supply at least 12 MT of Sensitized Cream Wove Chq. Paper.

The bidder should indicate the following information regarding capacity and performance:-

a) Name of the machine utilized to supply the quoted product.

b) The number of machines being utilized for the production and the capacity of each machine.

c) Total Annual Capacity of the manufacturer.

d) Supply orders in hand and proportionate capacity to supply quoted amount.

Note: At the discretion of the purchaser, the Capacity/Capability Assessment/Verification of bidder/ manufa cturer firm(s) might be undertaken by Tender Evaluation Committee or through a third party Technical Co nsultancy/ Inspection agencies to ensure that the firm is/are identified and capable to supply the item/mat erial/product as required.

(3) Financial Standing:

a) The average annual financial turnover of the Bidder during the last three years ending 31.03.2022 shoul d be more than Rs.26 lakhs as per the annual report (audited balance sheet and profit & loss account state ments) of the last three financial years ending 31.03.2022 duly authenticated by a Chartered Accountant/ Cost Accountant in India or equivalent in other countries.

Note: 'Startups and Micro and Small Enterprises' are exempted from 'Average Annual Turnover' as per MSE Policy.

b) The Bidder should not have suffered any financial loss for more than one year during the last three finan cial years ending on 31.03.2022.

c) (i) The net worth of the bidder should not be negative as on 31.03.2022.

(ii) The net worth of the bidder firm should not have eroded by more than 30% in the last three financial ye ars ending 31.03.2022.

Note:-

(1) Bidders have to furnish stipulated documents in support of fulfilment of Eligibility Criteria. Decision on f inalization of tender will be taken based on the documents submitted along with the tender.

(2) The credentials regarding experience and past performance to the extent will be verified by Security Pr inting Press, Hyderabad. The criteria for Capability, Equipment and Manufacturing facilities as well as finan cial loss and net worth under the financial standing eligibility criteria (above) shall be applicable to all the b idder firms including MSEs & Startup firms. All the data pertaining to financial experience, capability shoul d be of principal manufacturer.

(3) The bidder has to submit Power of Attorney/ Authorization indicating that authorized signatory is comp etent and legally authorized to submit the tender and / or enter into legally binding contract.

(4) Manufacturer Authorization Letter:- In case the bidder offers to supply subject material which is manufa ctured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated material to quote for and supply the same to Security Printing Press, a unit of SPMCIL. (7) Relaxation may also be given under Order No P-45021/2/2017-B.E.-II dt: 15.06.2017 for Public Procure ment (Preference to Make in India) issued by Ministry of Commerce and Industry, Department of Industry a nd Internal Trade (Public Procurement Section), and Order No 6/18/2019-PPD dt: 23.07.2020 for prior regist ration on procurement from bidders from a country or countries on ground of Defence of India and nationa I Security, issued by Ministry of Finance, department of Expenditure (Public Procurement Division).
