1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 2. Service & Support

(I) Special Conditions of Contract (SCC):-

(1) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered price c the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). (2) **Risk Purchase:** (a) If the supplier after submission of bid and due acceptance of the same i.e. after issue of Contract fails to abide by the terms and conditions of these bid documents, or fails to supply the deliverable s/provide the services as per delivery schedule given or at any time repudiates the contract, the purchaser sl all have the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternative and angement and supplier tendered value will be recovered from the supplier along with other incidental charge: , including taxes, insurance etc.

In case of procurement through alternative sources and if procurement price is lower, no benefit on this account will be passed onto the supplier.

(3) **Tender cancellation:** The Chief General Manager, Security Printing Press, Hyderabad, India reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to cancel the endering process and reject all tenders at any time prior to award of contract, without incurring any liability, v hatsoever to the affected tenderer or tenderers.

(4) **Termination of Contract:** Security Printing Press, Hyderabad reserves the right to terminate the contra t at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on account of si ch termination of the contract or variation in the quantity.

(6) Termination of Contract for Convenience: After placement of contract, there may be some unforesed n situation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to the supplier for cancellation of the contract, in whole or in part, for its (SPMCIL's) convenience, inter alia, indicating the date with effect from which the termination is to become effective. Depending on the merits of the case, the upplier may have to be suitably compensated on mutually agreed terms for terminating the contract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resultant contract.

(7) PVC Clause:- No Price Variation will be permitted.

(8) Price Adjustment Clause: No Price Adjustment allowed.

(VII) Other instructions/requirements:-

(1) Bidders have to furnish stipulated documents in support of fulfillment of Eligibility Criteria. Decision on finalization of bid will be taken based on the documents submitted along with the bid.

(2) Leaves will be given as per prevailing rules. In case any employee(s) goes on leave for more than the pern issible period, the remuneration will be paid to the firm on the basis of actual number of working days such a mployee (s) worked in SPP in the respective month.

(3) All the persons who are going to be sponsored by the firm on out-sourcing basis may be required to attend for interview at SPP, Hyderabad to assess their capability/suitability.

(4) Under no circumstances, the successful bidder should withdraw their offer during the tenure of the contrat. The successful bidder should not ask for cancellation of the order/contract under any reasons/pretext such a s that they have not permitted to supply the required manpower {i.e., for which the order is placed by the SP , Hyderabad} by any Institution/ Govt. - 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
