1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total QUANTITY.The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Security Printing Press, Hyderabad payable at Security Printing Press, Hyderabad

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

4. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of EMD, the FDR will be released in the favour of the bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

5. Forms of EMD and PBG

Bidders can also submit the EMD with Banker's Cheque in favour of

Bidder has to upload scanned copy / proof of the BC along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

6. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

7. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

8. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

(I) Special Conditions of Contract (SCC):-

(1) Bid Splitting/Parallel Contract:-

(a) The Purchaser reserves the right to place 100% quantity on lowest qualified bidder. However, the Purc haser also reserves the right to place parallel contracts on one or more firms without any prejudice to the c apacity of the L1 bidder, as given below. The provision of parallel contract is as under:-

- i. Bidder firm should not quote for less than 25% of the tender quantity; otherwise their offer w ould be considered as unresponsive. However, the evaluation will be made based on eligibility crit eria.
- ii. The rate quoted by L1 bidder will be counter offered to L2 bidder, without prejudice to the cap acity of the L1 bidder and if agreed orders shall be placed in the ratio of L1:L2 = 70:30 of the total t endered quantity. In case of non-acceptance of the counter offer by L2 bidder, a similar offer shall be made to L3, L4 and so on at the sole discretion of the purchaser.
- iii. However, purchaser also reserves the right to place Purchase Order for the 100% tendered qua ntity on the lowest qualified bidder.
- iv. In case of only one eligible bidder, the quantity will be allocated on the basis of quoted quantit y or 100% of the tendered quantity, whichever is less.

(b) Purchase Preference shall also be considered as per Govt. of India MSE Policy & Make in India Policy or ders and accordingly the quantity will be splitted.

(2) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the serv ices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights a nd remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damage s, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or pe rformance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and/or performance, the conditions incorporated under GCC sub-clause 24 above shall also apply. In all su ch cases GST would also be applicable on LD.

(3) Licenses and Permits: Wherever applicable, the successful bidder shall ensure himself and also satis fy the Chief General Manager, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting Corporation of India Limited, that the successful bidder possesses the legal licence / permit to use a partic ular product / process /design / patent. The successful bidder shall be held responsible for all the civil/crimi nal and tortuous consequences arising from any claim from any third party in this regard.

(4) **Risk Purchase:** (a) If the supplier after submission of tender and due acceptance of the same i.e. after issue of Notification of Award of Contract fails to abide by the terms and conditions of these tender docum ents, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contra ct, the purchaser shall have the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternat ive arrangement and supplier tendered value will be recovered from the supplier along with other incident al charges, including taxes, insurance etc.

In case of procurement through alternative sources and if procurement price is lower, no benefit on this ac count will be passed onto the supplier.

(5) **Tender cancellation:** The Chief General Manager, Security Printing Press, Hyderabad, India reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to canc el the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected tenderer or tenderers.

(6) **Termination of Contract:** Security Printing Press, Hyderabad reserves the right to terminate the cont ract at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on accoun t of such termination of the contract or variation in the quantity.

(7) Cancellation of Contract for Default: Without prejudice to any other remedy for breach of contract , like removal from the list of registered supplier, by written notice of default sent to the supplier, the contr act may be terminated in whole or in part:

(i) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, o r any extension thereof granted.

(ii) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.

(8) Termination of Contract for Convenience: After placement of contract, there may be some unfore seen situation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to t he supplier for cancellation of the contract, in whole or in part, for its (SPMCIL#s) convenience, inter alia, in dicating the date with effect from which the termination is to become effective. Depending on the merits o f the case, the supplier may have to be suitably compensated on mutually agreed terms for terminating th e contract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resultant contract.

(9) PVC Clause:- No Price Variation will be permitted.

(10) Warrantee Clause: Warranty applicable for 3 months from the date of last supply.

(11) Price Adjustment Clause: No Price Adjustment allowed.

(12) Any dispute in the matter will be under Hyderabad (Telangana) Jurisdiction only.

(13) No revised quotation will be permitted during the validity of the bid and no conditional bid shall be acc epted.

(II) Delivery Schedule:-

- (1) 1st lot of 1500 litres should be supplied within 30 days from the date of issue of Contract Order.
- (2) 2nd lot of 1500 litres should be supplied within 60 days from the date of issue of Contract Order but strictly after the supply of 1st lot.
- (3) 3rd lot of 1500 litres should be supplied within 90 days from the date of issue of Contract Order but strictly after the supply of 2nd lot.
- (4) 4^{th} lot of 1500 litres should be supplied within 120 days from the date of issue of Contract Orde r but strictly after the supply of 3rd lot.

Note:

(a) The above Delivery Schedule may be changed in case of any operational exigencies.

(b) If at any time during the currency of the contract, the supplier encounters conditions hindering timely d elivery of the goods and performance of services, the supplier shall promptly inform SPP, Hyderabad in wri ting about the same and its likely duration and make a request SPP, Hyderabad for extension of the deliver y schedule accordingly. On receiving the supplier's communication, SPP, Hyderabad shall examine the situ ation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the c ontract.

(c)The supplier shall not despatch the goods after expiry of the delivery period. The supplier is required to apply to SPP, Hyderabad for extension of delivery period and obtain the same before despatch. In case the supplier despatches the goods without obtaining an extension, it would be doing so at its own risk and no c laim for payment for such supply and / or any other expense related to such supply shall lie against SPP, H yderabad.

(III) Quality Control Requirements:-

The material will be accepted strictly as per Technical Specifications. If any defects are observed or the m aterial / service found unsuitable, then the same will be rejected and replace the same at supplier's / Servi ce Provider's own risk and cost.

(IV) Payment terms:- 100% payment within 30 days after receipt & acceptance of material by consignee as mentioned in Delivery schedule. No payment shall be made for rejected material.

Note: SPPH GST No. 36AAJCS6111J1Z9 should be mentioned in all the tax invoices and bills.

(V) Qualification/Eligibility Criteria:- The Bidder should meet the following eligibility criteria to qualify:-

(1) Experience and past performance: The bidder should have manufactured / supplied atleast 2400 li tres of Printing Rollers & Blanket Cleaning Solvent or similar material to any organisation in any one year d uring last five years.

Note: 'Startups and Micro and Small Enterprises' are exempted from Experience and Past Performance Crit eria as per the Startup Policy & MSE Policy.

(2) Capability-Equipment & Manufacturing Facilities: The bidder firm must have an annual capacity to Manufacture/supply at least 2400 litres of Printing Rollers & Blanket Cleaning Solvent and an undertakin g to be submitted along with the bid.

Note: At the discretion of the purchaser, the Capacity/Capability Assessment/Verification of bidder/ manufa cturer firm(s) might be undertaken by Tender Evaluation Committee or through a third party Technical Co nsultancy/ Inspection agencies to ensure that the firm is/are identified and capable to supply the item/mat erial/product as required.

Note:-

(1) Bidders have to furnish stipulated documents in support of fulfilment of Eligibility Criteria. Decision on f inalization of tender will be taken based on the documents submitted along with the tender.

(2) The credentials regarding experience and past performance to the extent will be verified by Security Pr inting Press, Hyderabad. The criteria for Capability, Equipment and Manufacturing facilities shall be applic able to all the bidder firms including MSEs & Startup firms. All the data pertaining to experience, capability should be of principal manufacturer.

(3) The bidder has to submit Power of Attorney/ Authorization indicating that authorized signatory is comp etent and legally authorized to submit the tender and / or enter into legally binding contract.

(4) Manufacturer Authorization Letter:- In case the bidder offers to supply subject material which is m anufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated m aterial to quote for and supply the same to Security Printing Press, a unit of SPMCIL. The bidder shall submit t the manufacturer's authorization letter to this effect. There can be only one bid from the principal manufacturer directly or one agent on his behalf.

(5) The bid is for manufacturers and suppliers who have proven capacity, capability and experience. This is not a Development Order.

(VI) Applicability in Special Cases:-

(1) For newly developed firms of this material: In case, of if newly developed firms (newly developed sources during this 3-year period of Development Commitment) who have completed the Development Or ders of SPPH with +/-5% tolerance, participate in this tender, then 20% out of the total required quantity i. e., 1200 litres of tender shall be reserved for newly developed firms subject to matching L1 rate.

(2) Newly developed firms of SPPH for this material are exempted from the above eligibility criteria point n o.V(1) i.e. Experience & Past Performance.

(3) If the rates quoted by a newly developed firm are lower than L1 rates of already developed firms - and i ts performance is considered reliable capable and satisfactory, Tender Evaluation Committee may take a d ecision to place an order upto 50% on such newly developed firms.

(4) For Existing successful Past Suppliers: In case the bidder (manufacturer or principal of authorised representative) who is a successful past supplier of subject material in at least one of the recent past thre e procurements, who do not meet any or more of requirements above, would also be considered to be qua lified in view of their proven credentials, for the maximum quantity supplied by them in such recent past. (This clause is not applicable for Security Items as notified by Government of India from time to time.)

(5) Joint Ventures and Holding Companies: Credentials of the partners of Joint ventures cannot (repea t cannot) be clubbed for the purpose of compliance of PQC in supply of Goods/Equipment, and each partne r must comply with all the PQC criteria independently. However, for the purpose of qualifying the Financial Standing Criteria, the Financial Standing credentials of a Holding Company can be clubbed with only one of the fully owned subsidiary bidding company, with appropriate legal documents proving such ownership.

(6) Applicability to 'Make in India': Bidders (manufacturer or principal of authorised representative) If t he product is being manufactured in India under a license from a foreign manufacturer who holds intellect ual property rights and where there is a technology collaboration agreement/ transfer of technology agree ment for indigenous manufacture of a product developed abroad with clear phased increase in local conte nt, and who while meeting all other criteria above, except for any or more of sub-criteria in Experience and Past Performance above, would also be considered to be qualified provided: i) their foreign manufacturer who holds intellectual property rights, meets all the criteria above without exemption, and ii) the Bidder su bmits appropriate documentary proof for technology collaboration agreement/ transfer of technology agree ement for indigenous manufacture of a product developed abroad with clear phased increase in local cont ent. iii) the bidder (manufacture of a product developed abroad with clear phased increase in local cont ent. iii) the bidder (manufacturer or principal of authorised representative) furnishes along with the bid a le gally enforceable undertaking jointly executed by himself and such foreign Manufacturer for satisfactory manufacture, Supply (and erection, commissioning if applicable) and performance of 'The Product' offered including all warranty obligations as per the general and special conditions of contract.

(7) Relaxation may also be given under Order No P-45021/2/2017-B.E.-II dt: 15.06.2017 for Public Procure ment (Preference to Make in India) issued by Ministry of Commerce and Industry, Department of Industry a nd Internal Trade (Public Procurement Section), and Order No 6/18/2019-PPD dt: 23.07.2020 for prior regist ration on procurement from bidders from a country or countries on ground of Defence of India and nationa I Security, issued by Ministry of Finance, department of Expenditure (Public Procurement Division).

(8) Important instructions for "Local Supplier":-

a) Minimum Local Content: The local content requirement to categorize a supplier as 'Class-I Local Supplie r'/'Class-II Local Supplier'/ 'Non-Local Supplier' shall be as defined in the Para"2" of the Order No. P-45021/2 /2017-PP(BE-II) dated 04th June,2020 issued by Department for Promotion of Industry and Internal Trade, M inistry of Commerce and Industry, Government of India.
