### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### 2. Forms of EMD and PBG

Bidders can also submit the EMD with Account Payee Demand Draft in favour of

Security Printing Press, Hyderabad payable at Security Printing Press, Hyderabad

Bidder has to upload scanned copy / proof of the DD along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date / Bid Opening date.

#### 3. Forms of EMD and PBG

Bidders can also submit the EMD with Fixed Deposit Receipt made out or pledged in the name of A/C (Name of the Buyer). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. #### 5. Certificates

#### 6. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 8. Buyer Added Bid Specific ATC

#### (I) Special Conditions of Contract (SCC):-

- (1) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the serv ices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights a nd remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damage s, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and/or performance, the conditions incorporated under GCC sub-clause 24 above shall also apply. In all su ch cases GST would also be applicable on LD.
- **(2) Licenses and Permits:** Wherever applicable, the successful bidder shall ensure himself and also satis fy the Chief General Manager, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting Corporation of India Limited, that the successful bidder possesses the legal licence / permit to use a partic ular product / process /design / patent. The successful bidder shall be held responsible for all the civil/crimi nal and tortuous consequences arising from any claim from any third party in this regard.
- (3) Risk Purchase: (a) If the supplier after submission of tender and due acceptance of the same i.e. after issue of Contract Order fails to abide by the terms and conditions of these tender documents, or fails to su pply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall have the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternat ive arrangement and supplier tendered value will be recovered from the supplier along with other incident al charges, including taxes, insurance etc.

In case of procurement through alternative sources and if procurement price is lower, no benefit on this ac count will be passed onto the supplier.

- **(4) Tender cancellation:** The Chief General Manager, Security Printing Press, Hyderabad, India reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected tenderer or tenderers.
- **(5) Termination of Contract:** Security Printing Press, Hyderabad reserves the right to terminate the cont ract at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on account of such termination of the contract or variation in the quantity.
- **(6) Cancellation of Contract for Default:** Without prejudice to any other remedy for breach of contract , like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:
- (i) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, o r any extension thereof granted.
- (ii) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.
- (7) Termination of Contract for Convenience: After placement of contract, there may be some unfore seen situation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to the supplier for cancellation of the contract, in whole or in part, for its (SPMCIL#s) convenience, inter alia, in dicating the date with effect from which the termination is to become effective. Depending on the merits of the case, the supplier may have to be suitably compensated on mutually agreed terms for terminating the contract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resultant contract.
- (8) PVC Clause:- No Price Variation will be permitted.
- (9) Price Adjustment Clause: No Price Adjustment allowed.
- (10) Any dispute in the matter will be under Hyderabad (Telangana) Jurisdiction only.
- (11) No revised quotation will be permitted during the validity of the bid and no conditional bid shall be acc epted.

## (II) Delivery Schedule:-

- (1) 1<sup>st</sup> lot of 200 Ltrs. should be supplied within 30 days from the date of issue of Contract Order.
- (2) 2<sup>nd</sup> lot of 1600 Ltrs. should be supplied within 60 days from the date of issue of Contract Order.

#### Note:

- (a) The above Delivery Schedule may be changed in case of any operational exigencies.
- (b) If at any time during the currency of the contract, the supplier encounters conditions hindering timely d elivery of the goods and performance of services, the supplier shall promptly inform SPP, Hyderabad in wri ting about the same and its likely duration and make a request SPP, Hyderabad for extension of the deliver y schedule accordingly. On receiving the supplier's communication, SPP, Hyderabad shall examine the situ ation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.

(c)The supplier shall not despatch the goods after expiry of the delivery period. The supplier is required to apply to SPP, Hyderabad for extension of delivery period and obtain the same before despatch. In case the supplier despatches the goods without obtaining an extension, it would be doing so at its own risk and no c laim for payment for such supply and / or any other expense related to such supply shall lie against SPP, H yderabad.

#### (III) Quality Control Requirements:-

The material will be accepted strictly as per Technical Specifications. If any defects are observed or the m aterial / service found unsuitable, then the same will be rejected and replace the same at supplier's / Service Provider's own risk and cost.

(IV) Payment terms:- 100% payment within 30 days after receipt & acceptance of material by consignee as mentioned in Delivery schedule. No payment shall be made for rejected material.

Note: SPPH GST No. 36AAJCS6111J1Z9 should be mentioned in all the tax invoices and bills.

- (V) Qualification/Eligibility Criteria:- The Bidder should meet the following eligibility criteria to qualify:-
- (1) Experience and past performance: The bidder should have manufactured/ supplied atleast 720 Ltr s. of similar material of Isopropyl alcohol to any organisation in any one year during last five years.

Note: 'Startups and Micro and Small Enterprises' are exempted from Experience and Past Performance Crit eria as per the Startup Policy & MSE Policy.

#### Note:-

- (1) Bidders have to furnish stipulated documents in support of fulfilment of Eligibility Criteria. Decision on f inalization of tender will be taken based on the documents submitted along with the tender.
- (2) The credentials regarding experience and past performance to the extent will be verified by Security Pr inting Press, Hyderabad. All the data pertaining to experience, capability should be of principal manufactur er.
- (3) The bidder has to submit Power of Attorney/ Authorization indicating that authorized signatory is competent and legally authorized to submit the tender and / or enter into legally binding contract.
- **(4) Manufacturer Authorization Letter:-** In case the bidder offers to supply subject material which is m anufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated m aterial to quote for and supply the same to Security Printing Press, a unit of SPMCIL. The bidder shall submit the manufacturer's authorization letter to this effect. There can be only one bid from the principal manufacturer directly or one agent on his behalf.
- (5) The bid is for manufacturers and suppliers who have proven capacity, capability and experience. This is not a Development Order.

### (VI) Important instructions for "Local Supplier":-
