PART - I: TECHNO-COMMERCIAL BID:

These bids shall be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the Second stage the Financial/ Price bids of only the technically acceptable offers (as decided in the first stage) shall be opened for further scrutiny and evaluation. Intimation regarding opening of Financial/ Price bids shall be given to technically acceptable tenderers to enable them to attend the financial bid opening, if they so desire. - 11. 
