- 1.) Visual observations of structure. In this study visual observation indicating any signs of distress in RCC members like beams, columns and roof slabs should be carried out. Visual observations data should be supplemented by photographs & other pertinent information wherever available.
- 2.) Quality assessment of selected RCC members using Rebound Hammer testing technique as per IS:516(PART 5/Sec 4):2020 on few selected safely accessible locations by using random sampling technique. Total number of locations may minimum 20 nos.
- 3.) Carry out Ultra Sonic Pulse Velocity (UPV) testing of RCC members like beam, column and roof slabs as per IS:516(PART 5):2018 to ascertain the homogeneity of the concrete in selected RCC members. The representative testing samples from different locations shall be selected by random sampling technique. The total number of locations:- 20 nos.
- 4.) Determination of equivalent cube compressive strength of concrete in RCC members like beams, coloumns and roof slabs using concrete core exaction & testing technique as per IS:456-2000 & IS:516-2018. The representative concrete core samples drawn from different locations of RCC members shall be selected by random sampling technique. Total number of concrete cores extracted from different RCC members. Qty:- 15 nos.
- 5.) Carbonation study shall be conducted on concrete cores extracted from above pt.4.
- 6.) Determination of corrosion status of reinforcement steel using half cell potential survey as per IS:516(part 5/sec 2):2021 on few selected safely accessible locations of RCC members. Total number of locations shall be minimum 10 nos.
- 7.) Determination of concrete cover thickness in RCC members like beams, columns and roof slabs using ferro scanning at identified & safely accesible locations. Total number of locations minimum 15 nos.
- 8.) Chemical analysis to determine chloride content, Sulphate Content & pH value of concrete powder samples in laboratory. Total number of samples:- min 10 nos.
- 9.) To evaluate & interpret all the test results on the present condition of existing building with respect to quality, integrity and strength to carry the load capability.
- 10.) To formulate recommendations & remedial measures including repair & restoration wherever applicable and assessment of terrace roof slab strength to carry additional machinery load.
