- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are

advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. Scope of Supply

Scope of supply (Bid price to include all cost components): Only supply of Goods

#### 3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## 4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

#### (I) Special Conditions of Contract (SCC):-

- (1) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the serv ices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights a nd remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damage s, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or pe rformance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and/or performance, the conditions incorporated under GCC sub-clause 24 above shall also apply. In all su ch cases GST would also be applicable on LD.
- **(2) Licenses and Permits:** Wherever applicable, the successful bidder shall ensure himself and also satis fy the Chief General Manager, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting Corporation of India Limited, that the successful bidder possesses the legal licence / permit to use a partic ular product / process /design / patent. The successful bidder shall be held responsible for all the civil/crimi nal and tortuous consequences arising from any claim from any third party in this regard.
- (3) Risk Purchase: (a) If the supplier after submission of tender and due acceptance of the same i.e. after issue of Contract fails to abide by the terms and conditions of these tender documents, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall he ave the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternative arrangement and supplier tendered value will be recovered from the supplier along with other incident

al charges, including taxes, insurance etc.

In case of procurement through alternative sources and if procurement price is lower, no benefit on this ac count will be passed onto the supplier.

- **(4) Tender cancellation:** The General Manager & HOD, Security Printing Press, Hyderabad, India reserve s the right to accept in part or in full any tender or reject any tender without assigning any reason or to cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring a ny liability, whatsoever to the affected tenderer or tenderers.
- **(5) Termination of Contract:** Security Printing Press, Hyderabad reserves the right to terminate the cont ract at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on account of such termination of the contract or variation in the quantity.
- **(6) Cancellation of Contract for Default:** Without prejudice to any other remedy for breach of contract , like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:
- (i) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, o r any extension thereof granted.
- (ii) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.
- (7) Termination of Contract for Convenience: After placement of contract, there may be some unfore seen situation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to t he supplier for cancellation of the contract, in whole or in part, for its (SPMCIL#s) convenience, inter alia, in dicating the date with effect from which the termination is to become effective. Depending on the merits o f the case, the supplier may have to be suitably compensated on mutually agreed terms for terminating th e contract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resultant contract.
- **(8) Resolution of Disputes:** Contractual disputes for resolution through arbitration to the India International Arbitration Centre (IIAC), New Delhi.
- (9) Price Adjustment Clause: No Price Adjustment allowed.
- (10) Shelf Life: One year from the date of manufacturing.
- (11) No revised quotation will be permitted during the validity of the bid and no conditional bid shall be acc

epted.

## (II) Delivery Schedule:-

- (1) 1<sup>st</sup> lot of 5 kgs to be supplied within 15 days from the date of issue of Contract Order.
- (2) 2<sup>nd</sup> lot of 70 kgs to be supplied within 45 days from the date of issue of Contract Order but strictly after supply of 1<sup>st</sup> lot.
- (3) 3<sup>rd</sup> lot of 100 kgs to be supplied within 135 days from the date of issue of Contract Order but stric tly after supply of 2<sup>nd</sup> lot.
- (4) 4<sup>th</sup> lot of 125 kgs to be supplied within 225 days from the date of issue of Contract Order but stric tly after supply of 3<sup>rd</sup> lot.

#### Note:

- (a) The above Delivery Schedule may be changed in case of any operational exigencies.
- (b) If at any time during the currency of the contract, the supplier encounters conditions hindering timely d elivery of the goods and performance of services, the supplier shall promptly inform SPP, Hyderabad in writing about the same and its likely duration and make a request SPP, Hyderabad for extension of the deliver y schedule accordingly. On receiving the supplier's communication, SPP, Hyderabad shall examine the situ ation as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the contract.
- (c)The supplier shall not despatch the goods after expiry of the delivery period. The supplier is required to apply to SPP, Hyderabad for extension of delivery period and obtain the same before despatch. In case the supplier despatches the goods without obtaining an extension, it would be doing so at its own risk and no c laim for payment for such supply and / or any other expense related to such supply shall lie against SPP, H yderabad.
- (d) Vendor is responsible for unloading of their material at Stores of Security Printing Press, Hyderabad.

#### (III) Quality Control Requirements:-

The material will be accepted strictly as per Buyer Specifications. If any defects are observed or the material / service found unsuitable, then the same will be rejected and must be replaced at Supplier's / Service P rovider's own risk and cost.

### (IV) Payment terms:-

Payment will be made after receipt & acceptance of material by consignee as mentioned in Delivery sched ule. No payment shall be made for rejected material.

Note: SPPH GST No. 36AAJCS6111J1Z9 should be mentioned in all the tax invoices and bills.

### (V) Qualification/Eligibility Criteria:-

- (1) The bidder must be capable to supply subject material as per specifications and delivery schedule.
- **(2) Manufacturer Authorization Letter:-** In case the bidder offers to supply subject material which is m anufactured by some other firm, the bidder has to be duly authorized by the manufacturer of the stated m aterial to quote for and supply the same to Security Printing Press, a unit of SPMCIL. The bidder shall submi t the manufacturer's authorization letter to this effect. There can be only one bid from the principal manuf acturer directly or one agent on his behalf.
- (3) The bidder must provide requisite documents as sought in the bid or otherwise the bid is liable for rejection.

It may be noted that the price is not to be quoted in Technical bid. It shall only be quoted in Price bid. Non-adherence to this shall make tender liable for rejection.

#### (IX) Conditions for Micro and Small Enterprises (MSEs):-

(i) As per Public Procurement Policy (PPP) for Micro & Small Enterprises (MSEs) Order, 2012 issued vide Ga zette Notification dated 23.03.2012 by Ministry of Micro, Small and Medium Enterprises of Gov. of India, MS Es must be registered with any of the following in order to avail the benefits / preference available vide Pu blic Procurement Policy MSEs Order, 2012.

- b) Khadi and Village Industries Commission (KVIC)

- d) Coir Board
- e) National Small Industries Corporation (NSIC)
- f) Directorate of Handicraft and Handloom
- g) Any other body specified by Ministry of MSME (MoMSME)
- h) Udyog Aadhaar Acknowledgment / Udyog Aadhaar Memorandum issued by MoMSME.
- (ii) MSEs participating in the tender must submit valid & authorized copy of certificate of registration with a ny one of the above agencies. In case of bidders submitting DIC registration certificate shall attach original notarised copy of the DIC certificate. The MSE's Bidder to note and ensure that nature of services and good s / items manufactured mentioned in MSEs certificate matches with the nature of the services and goods / items to be supplied as per Tender.
- (iii) Traders / resellers / distributors / authorized agents will not be considered for availing benefits under P P Policy 2012 for MSEs as per MSE guidelines issued by MoMSME.
- (iv) The registration certificate issued from any one of the above agencies must be valid as on Bid closing date of the tender. Bidder shall ensure validity of registration certificate in case bid closing date is extende d.
- (v) The MSEs who have applied for registration or renewal of registration with any of the above agencies / bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemp tion / preference.
- (vi) Relaxation of Norms for Micro & Small Enterprises (MSEs): Pre-qualification criteria with respect to Prio r Turnover and Prior experience is relaxed for Micro & Small Enterprises as per GOI guidelines subject to m eeting of quality and technical specifications.

## (X) Conditions for Start-Up Companies:-

- (i) Start-up Enterprises: Requirements of prior experience and turnover would be relaxed for Start-up enter prises as recognised by Department for Promotion of Industry and Internal Trade (DPIIT), subject to their m eeting the quality and technical specifications. Such Start-ups maybe either MSE or otherwise.
- (ii) Subject to meeting of Quality and Technical Specifications, SPP may consider allowing the participation of "Start up" companies with capability to execute the supply / services, as per technical specifications / p

erform the job as per scope of work specified in the tender and subject to meeting extant & relevant guid elines of Government of India. This should be confirmed and substantiated in the technical bid.

- (iii) The bidder who intends to participate as "Start up" company should enclose the Certificate of Recognit ion issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of Ind ia during submission of Technical bid.
- (iv) Pre-qualification criteria with respect to Prior Turnover and Prior experience is relaxed for Start up Ente rprises as per GOI guidelines subject to meeting of guality and technical specifications.
- (v) However, there may be circumstances like procurement of items / services related to public safety, he alth, critical security operations and equipment, etc wherein SPP reserves the right to not consider relaxati on of Prior Turnover and Prior Experience for Start up Companies as per GOI guidelines.
- (vi) Start up Companies who are also registered as MSEs and wish to avail the benefits as applicable to MS E, shall submit relevant documents covered under Conditions for Micro and Small Enterprises elsewhere in this tender.

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 7. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

### 8. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. - 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
