1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to gualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are

advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 <u>OM_No.1_4_2021_PPD_dated_18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

(I) Special Instructions to Tenderers:-

(1) Bid Splitting/Parallel Contract:-

(a) The Purchaser reserves the right to place 100% quantity on lowest qualified bidder. However, the Purc haser also reserves the right to place parallel contracts on one or more firms without any prejudice to the c apacity of the L1 bidder, as given below. The provision of parallel contract is as under:-

- i. Bidder firm should not quote for less than 25% of the tender quantity; otherwise their offer w ould be considered as unresponsive. However, the evaluation will be made based on eligibility crit eria.
- ii. The rate quoted by L1 bidder will be counter offered to L2 bidder, without prejudice to the cap acity of the L1 bidder and if agreed orders shall be placed in the ratio of L1:L2 = 70:30 of the total t endered quantity. In case of non-acceptance of the counter offer by L2 bidder, a similar offer shall be made to L3, L4 and so on at the sole discretion of the purchaser.
- iii. However, purchaser also reserves the right to place Purchase Order for the 100% tendered qua ntity on the lowest qualified bidder in case any of the L2, L3 and so on does not accept L1 rates.
- iv. In case of only one eligible bidder, the quantity will be allocated on the basis of quoted quantit y or 100% of the tendered quantity, whichever is less.

(b) Purchase Preference shall also be considered as per Govt. of India MSE Policy & Make in India Policy or ders issued from time to time and accordingly the quantity will be distributed.

(2) **Tender cancellation:** The General Manager & HOD, Security Printing Press, Hyderabad, India reserve s the right to accept in part or in full any tender or reject any tender without assigning any reason or to ca ncel the tendering process and reject all tenders at any time prior to award of contract, without incurring a ny liability, whatsoever to the affected tenderer or tenderers.

(3) The Security Deposit/EMD documents viz., Bank Guarantee, Demand Draft / Fixed Deposit Receipt mus t be in the printed form in favor of "Security Printing Press, Hyderabad." Any handwritten documents will n ot be accepted.

(4) Licenses and Permits: Wherever applicable, the successful bidder shall ensure himself and also satis fy the General Manager & HOD, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting Corporation of India Limited, that the successful bidder possesses the legal licence / permit to use a partic ular product / process /design / patent. The successful bidder shall be held responsible for all the civil/crimi nal and tortuous consequences arising from any claim from any third party in this regard.

(5) Price Variation & Price adjustment are not allowed. No revised quotation will be permitted during the validity of the bid and no conditional bid shall be accepted.

(II) Special Conditions of Contract (SCC):-

(1) **Delivery Schedule:-** The material has to be supplied in staggered manner as detailed above.

- a) If at any time during the currency of the contract, the supplier encounters conditions hindering timely deli very of the goods and performance of services, the supplier shall promptly inform SPP, Hyderabad in writin g about the same and its likely duration and make a request SPP, Hyderabad for extension of the delivery s chedule accordingly. On receiving the supplier's communication, SPP, Hyderabad shall examine the situati on as soon as possible and, at its discretion, may agree to extend the delivery schedule, with or without liq uidated damages for completion of supplier's contractual obligations by issuing an amendment to the cont ract.
- b) The supplier shall not despatch the goods after expiry of the delivery period. The supplier is required to a pply to SPP, Hyderabad for extension of delivery period and obtain the same before despatch. In case the s upplier despatches the goods without obtaining an extension, it would be doing so at its own risk and no cl aim for payment for such supply and / or any other expense related to such supply shall lie against SPP, Hy derabad.
- c) Vendor is responsible for unloading of their material at Stores Department of Security Printing Press, Hyd erabad.
- d) The Delivery Schedule may be changed in case of any operational exigencies.

(2) Quality Control Requirements:-

The material will be accepted strictly as per Buyer Specifications. If any defects are observed or the materi al / service found unsuitable, then the same will be rejected and replace the same at supplier's / Service Pr ovider's own risk and cost.

(3) Warrantee Clause: Warranty applicable for 3 months from the date of last supply.

(4) Liquidated Damages: Subject to GCC clause 28, if the supplier fails to deliver any or all of the goods

or fails to perform the services within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights and remedies available to SPMCIL under the contract, deduct from the contract pr ice, as liquidated damages, a sum equivalent to the ½% percent (or any other percentage if prescribed in t he SCC) of the delivered price of the delayed goods and/ or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% (or any other percentag e if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above-mentione d delayed period of supply and / or performance, the conditions incorporated under GCC sub-clause 23.4 a bove shall also apply. In all such cases GST would also be applicable on LD.

(5) **Termination of Contract for Default:** Security Printing Press, Hyderabad without prejudice to any o ther contractual rights and remedies available to it, may, by written notice of default sent to the supplier, terminate the contract in whole or in part, if the supplier fails to deliver any or all of the goods or fails to pe rform any other contractual obligation(s) within the time period specified in the contract, or within any ext ension thereof granted by SPMCIL pursuant to GCC sub-clauses 23.3 and 23.4.

(6) **Risk Purchase:** In the event of SPMCIL terminates the contract in whole or in part, pursuant to GCC s ub-clause 26.1 above, SPMCIL may procure goods and/ or services similar to those cancelled, with such ter ms and conditions and in such manner as it deems fit at the Risk and Cost of the supplier and the supplier shall be liable to SPMCIL for the extra expenditure, if any, incurred by SPMCIL for arranging such procurem ent.

(7) Termination of Contract for Convenience: Security Printing Press, Hyderabad reserves the right to terminate the contract, in whole or in part for its (SPPH's) convenience, by serving written notice on the su pplier at any time during the currency of the contract. The notice will specify that the termination is for the convenience of SPP, Hyderabad. The notice will also indicate inter-alia, the extent to which the supplier's p erformance under the contract is terminated, and the date with effect from which such termination will bec ome effective.

(8) **Resolution of Disputes:** Contractual disputes for resolution through arbitration to the India Internati onal Arbitration Centre (IIAC), New Delhi.

(III) Qualification/Eligibility Criteria:-

(1) The bidder firm should meet following eligibility criteria to qualify:-

(a) For MSE/Start-up firm: Capability - Equipment & Manufacturing Facilities: The bidder firm should have c apability to manufacture and supply of tendered item.

Note: At the discretion of the purchaser, the Capacity/Capability Assessment/Verification of bidder/ manufa cturer firm(s) might be undertaken by Tender Evaluation Committee or through a third party Technical Co nsultancy/ Inspection agencies to ensure that the firm is/are identified and capable to supply the item/mat erial/product as required.

(b) For other firm - Experience and past performance: The bidder firm may be Manufacturer/Proven suppli er/Authorized dealer or distributor of tendered item or bidder may participate with manufacturing authoriz ation form (issued by manufacturer of tendered item).
