- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. - 2. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. - 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 7. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 9. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 40% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

(I) Special Conditions of Contract (SCC):-

(1) Bid Splitting/Parallel Contract:-

- (a) Purchase Preference shall also be considered as per Govt. of India MSE Policy & Make in India Policy or ders and accordingly the quantity will be splitted.
- (b) The Purchaser reserves the right to place 100% quantity on lowest qualified bidder. However, the Purchaser also reserves the right to place parallel contracts on one or more firms without any prejudice to the capacity of the L1 bidder, as given below. The provision of parallel contract is as under:
 - i. The rate quoted by L1 bidder will be counter offered to L2 bidder, without prejudice to the ca pacity of the L1 bidder and if agreed orders shall be placed in the ratio of L1:L2 = 70:30 of the total tendered quantity. In case of non-acceptance of the counter offer by L2 bidder, a similar offer shall be made to L3, L4 and so on at the sole discretion of the purchaser.
 - ii. However, purchaser also reserves the right to place Purchase Order for the 100% tendered quantity on the lowest qualified bidder in case any of the L2, L3 and so on does not accept L1 rates.
 - iii. In case of only one eligible bidder, the quantity will be allocated on the basis of quoted quantity or 100% of the tendered quantity, whichever is less.
- (2) Liquidated Damages: If the supplier fails to deliver any or all of the goods or fails to perform the serv ices within the time frame(s) incorporated in the contract, SPMCIL shall, without prejudice to other rights a nd remedies available to SPMCIL under the contract, deduct from the contract price, as liquidated damage s, a sum equivalent to the 0.5% percent (or any other percentage if prescribed in the SCC) of the delivered price of the delayed goods and/or services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% (or any other percentage if prescribed in the SCC) of the delayed goods' or services' contract price(s). During the above mentioned delayed period of supply and/or performance, the conditions incorporated under GCC sub-clause 24 above shall also apply. In all su ch cases GST would also be applicable on LD.

- (3) Licenses and Permits: Wherever applicable, the successful bidder shall ensure himself and also satis fy the Chief General Manager, Security Printing Press, Hyderabad, a Unit of Security Printing And Minting C orporation of India Limited, that the successful bidder possesses the legal licence / permit to use a particul ar product / process /design / patent. The successful bidder shall be held responsible for all the civil/crimin al and tortuous consequences arising from any claim from any third party in this regard.
- **(4) Risk Purchase:** (a) If the supplier after submission of tender and due acceptance of the same i.e. after issue of Contract fails to abide by the terms and conditions of these tender documents, or fails to supply the deliverables as per delivery schedule given or at any time repudiates the contract, the purchaser shall h ave the right to:

i: Invoke the Security-cum-Performance Guarantee if deposited by the supplier and procure stores/services from other agencies at the risk and consequence of the supplier. The cost difference between the alternat ive arrangement and supplier tendered value will be recovered from the supplier along with other incident all charges, including taxes, insurance etc.

In case of procurement through alternative sources and if procurement price is lower, no benefit on this ac count will be passed onto the supplier.

- **(5) Tender cancellation:** The Chief General Manager, Security Printing Press, Hyderabad, India reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to canc el the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected tenderer or tenderers.
- **(6) Termination of Contract:** Security Printing Press, Hyderabad reserves the right to terminate the cont ract at any stage by giving one week's notice. No claim whatsoever shall lie against the SPMCIL on account of such termination of the contract or variation in the quantity.
- (7) Cancellation of Contract for Default: Without prejudice to any other remedy for breach of contract , like removal from the list of registered supplier, by written notice of default sent to the supplier, the contract may be terminated in whole or in part:
- (i) If the supplier fails to deliver any or all of the stores within the time period(s) specified in the contract, o r any extension thereof granted.
- (ii) If the supplier fails to perform any other obligation under the contract within the period specified in the contract or any extension thereof granted.
- **(8) Termination of Contract for Convenience:** After placement of contract, there may be some unfore seen situation compelling SPMCIL to cancel the contract. In such a case, a suitable notice is to be sent to t he supplier for cancellation of the contract, in whole or in part, for its (SPMCIL#s) convenience, inter alia, in dicating the date with effect from which the termination is to become effective. Depending on the merits o f the case, the supplier may have to be suitably compensated on mutually agreed terms for terminating th e contract. Suitable provisions to this effect are to be incorporated in the tender document as well as in the resultant contract.
- **(9) PVC Clause:** No Price Variation will be permitted.

- (10) Warrantee Clause: Warranty applicable for 3 months from the date of last supply.
- (11) Price Adjustment Clause: No Price Adjustment allowed.
- (12) Any dispute in the matter will be under IIAC (India International Arbitration Center), New Delhi.
- (13) No revised quotation will be permitted during the validity of the bid and no conditional bid shall be acc epted.

Note:

(a) The above Delivery Schedule may be changed in case of any operational exigencies.

- (b) If at any time during the currency of the contract, the supplier encounters conditions hindering timely d elivery of the goods and performance of services, the supplier shall promptly inform SPP, Hyderabad in wri ting about the same and its likely duration and make a request SPP, Hyderabad for extension of the deliver y schedule accordingly.
